SPECIAL ₹ 75 COIN TO MARK NEW PARLIAMENT BUILDING'S OPENING BY PM MODI

New Delhi: A special ₹ 75 coin will be launched to commemorate the inauguration of the new parliament building, the Ministry of Finance said on Thursday. The commemorative coin will serve as a tribute to India celebrating 75 years of independence and will be unveiled by Prime Minister Narendra Modi on Sunday.

One side of the coin will feature the Lion Capital of the Ashoka Pillar, with the words "Satyamev Jayate" below it. The word "Bharat" will be written in Devanagari script on the left side, and the word "India" in English on the right.

The coin will also have the rupee symbol and the denomination value of 75 in international numerals written below the Lion Capital. The other side of the coin will show an image of the parliament complex. The words "Sansad Sankul" will be written in Devanagari script on the upper periphery and "Parliament Complex" in English on the lower periphery.

Over a trivial issue, a man attacked his wife and daughter with a knife, leading to the death of his 19-year-old daughter in Gujarat's Surat district Friday night. The wife and daughter wanted to sleep on the terrace of the house while the man insisted they sleep in the room, which led to an altercation.

Kadodara police inspector R S Patel said the accused, Ramanuj Sahoo (45), a resident of Satyanarayan Nagar society in Kadodara village in Palsana taluka of Surat district, works at a dyeing and printing mill in GIDC at Kadodara with his wife Rekhadevi. The couple hails from the Siwan district of Bihar and has three children, including the deceased Chandakumari (19), and two minor sons

The police said, on Friday night, the couple returned home from the job and after having dinner, Rekhadevi along with her children took the bedsheet to the terrace of the building. Ramanuj objected and asked them to sleep inside the house but she denied.

A heated exchange of words ensued and Sahoo took a knife from the kitcher and attacked Rekhadevi, who received injuries on her right hand, while Chandakumari tried to stop her father. The father and daughter reportedly engaged in fisticuffs which further enraged Sahoo and he stabbed his daughter several times with the knife resulting in her death on the spot. Police in Maharashtra's Thane have registered a case against an Army jawan posted with the Bombay Engineer Group and Centre located in Pune city for allegedly raping a 30-year-old woman constable he had befriended on social media

Police in Maharashtra's Thane have registered a case against an Army jawan posted with the Bombay Engineer Group and Centre located in Pune city for allegedly raping a 30-year-old woman constable he had befriended on social media, an official said on Thursday.

The accused was also booked under the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act based on a complaint lodged by the woman, he said.

'The victim works as a constable with the Mumbai police and lives alone at Kalyan in Thane district. Around one-and-a-half years back, she met the accused on social media and soon friendship grew between them," the police official said.

The accused, who is posted as a 'DI trainer' at the Bombay Engineer Group, hails from Beed. In 2022, the accused met the victim for the first time at her residence and offered a drink laced with sedatives before raping her. He repeated the offence multiple times till May this year on the promise of marrying her, the police said.

But recently, he told the woman that he cannot marry her as she belonged to a tribal community, they said.

The woman then lodged the complaint at Kolsewadi police station, based on which the accused was booked under Indian Penal Code (IPC) sections 376(2)(n) (repeated rape) and 328 (causing hurt by means of poison, etc) and the SC/ST (Prevention of Atrocities) Act, the police said, adding that he was not arrested vet.

He had also posted photos with the CM on his social media profile. Palande showcased a true caller profile displaying the CMO and even created a WhatsApp message, posing as its PRO.

Scam exposed by college delegations A complaint to this effect was lodged by Nitin U Pansare of the CMO with the Hinjewadi police station, Pune, which registered an FIR in the admission scam on Tuesday

The lid from the scam blew off when a delegation of Symbiosis International University and another institution called on the CM at a function in Pune on Sunday. A member of the delegation informed the officials that following purported 'requests' from the CMO, they had given admissions to four students in Pune, Lavale, Hinjewadi and Bengaluru.
